## GENERAL CONDITIONS

1. Solutions shall contain a minimum of 35 percent of mass of pure calcium chloride and shall not contain impurities in excess of 2 percent by mass. Solutions strength shall be determined at 15.6° Celsius and shall conform to O.P.S.S. #2501, Nov. 2001.
2. Only products approved by Ministry of Environment and Energy for use as dust suppressants will be accepted.
3. A copy of a valid letter of agreement from the Ministry of Environment and Energy shall be supplied with tender submissions as well as M.S.D.S. sheets for product used.
4. Price per litre, as applied to the road surface, shall be quoted. Application equipment shall have measuring device to measure product used and the device shall be in working order. A conversion factor of 1.35 kg. (per kilometer) /L shall be used in converting the volume of solution to equivalent mass of solution.
5. All operations will conform to all Provincial, Federal and other Acts pertaining to work being performed.
6. All operations will be performed with promptness, efficiency and in a manner satisfactory to the Works Superintendent. Approximately 20 hours are required to perform said work.
7. The amounts may be increased or decreased based on budgetary allocations.
8. The liquid calcium application shall be completed by June 30, 2018.
9. Township tender form must be used.
10. Submissions sent by facsimile will **NOT BE ACCEPTED**.
11. Tenders will be received by the Township of South Algonquin Municipal Office until Thursday, May 24, 2018 at 3:30 pm.
12. Material shall conform to O.P.S.S. 2501.
13. The solution shall be applied by a tanker distributor.
