**UNFINISHED BUSINESS:**

- Discussion and review of the proposed changes to the Waste Management By-Law 14-454. During the discussion staff was directed to contact Drain All to inquire what the fees would be to host an additional event. It was also expressed paint cans are the most expensive item to recycle. Paint cans that have dried paint can be disposed at the landfill sites.
- Battery and cell phones can be disposed at Municipal Buildings that have boxes. Staff will advertise the program in the upcoming newsletters.

**NEW BUSINESS:**

- Reviewed and discussed the circulated letter provided by Kevin Mooder, Jp2g Consultant that included a revised budget for the Lyell Landfill Site expansion and the additional fee of \$1740.00 for the sediment sampling and additional water analysis sampling as requested by Laurel Rudd, Surface Water Evaluator of the MOECC. A resolution will be brought forward at the next regular Council.
- A letter from the Airy Landfill Site Attendant was circulated that included the efficiencies of the layout and suggestions on how to make the landfill site run more smoothly such as; magnetic sign for the electronic bin, a sign indicating no food in the

shred pile and it was also suggested that signage be erected at the Galeairy Lake Boat Launch directing interior park users to take their waste to Algonquin Park.

- Lyell Landfill Site has a user increase of 35% since 2014, Airy Landfill Site has a user increase of 20% since 2014.

The next Roads/ Waste Management Meeting is scheduled for October 12, 2016.
